IMPORTANT – PLEASE READ Organisation of TOMCC NZ Inc

Members of our club committee have noticed a lack of appreciation or understanding by many members of the way our club is organised around the country, so here is an attempt to remedy this

Firstly, and most importantly, we are an Incorporated Society, a national organisation to which all of us belong when we are accepted for membership. We are all equally entitled to Club and Area resources, benefits and events regardless of how long we have been in the club or where we live.

For the purposes of ease of communication and administration we currently have nine Areas or Chapters, of TOMCC NZ. Each Area has an elected Area Co-ordinator who represents the national body. Members' questions or concerns should in the first instance be directed to the Area Co-ordinator, as again, this person represents the national body. If they are unable to address a particular concern or answer a question themselves, they will put the question or concern out to their fellow national body members for discussion or an answer and then get back to you.

ALL members are covered by one of the following Areas, (or Chapters) of TOMCC NZ: Northland, Auckland, Franklin, Waikato / Bay of Plenty, Taranaki. Whanganui. Manawatu.

Canterbury, Otago / Southland. Any member regardless of where they live may be listed as a local member in any Area they choose. For example, a member living in Gisborne may choose to be listed under Whanganui.

With respect to geographical regions of the country some of our Areas consist of more than one geographical region than is indicated in the Area's name and this does not truly reflect the coverage of the members in a given Area.

Those who have read the September 2019 issue of *Triumph Times*, may remember an article (page 10) from the Otago Southland Area entitled "Distance is no Barrier". The size and scale of the South Island is not truely reflected in the names used by the two chapters that cover the South Island. The Otago Southland Chapter covers the lower 3rd of the South Island south of a line from the Haast river mouth across to the Waitaki river mouth.

North of that line is administered by Canterbury. Many of the 125 members listed under the Canterbury Area also live on the West Coast and in the Tasman and Marlborough regions. Marlborough itself was once a former Area of TOMCC NZ.

Likewise, as formed Areas of the club come and go, the Manawatu Area itself has been re-established 3 times and now covers members from the former Wellington, Hawke's Bay, Central Plateau / Ruapehu, Rotorua Chapters.

As our club Areas cover such large regions it is very important that consideration is taken of members who are living in the more remote parts of an Area. These members need to be given as many opportunities as possible, to take part in, or create, Club or Area activities, and have equal access to benefits and resources of the Area.

On the outer edges of an area? Call for a get together, set a date and a place, then inform the area coordinator who will pass it on to the members.

Given what has been discussed in this article, if you are further away from the main group of members and would like to see your own Area established, one may reasonably ask, why not give it a go?

At the end of the day you joined a Triumph motor cycle club so call for a meeting to gauge interest from your fellow members in reforming an area or creating a new area. You only need a minimum of 5 paid up members, one of whom is willing to act as Area Coordinator. It's not difficult, you only need to keep in regular email contact with other members in your Area.

27th TOMCC NZ **National Rally,** Te Anau, NZ

Another year, another rally, and by all accounts, a very successful rally. As those of you who know, it's a lot of hard work and personal time dedicated to creating our only annual event, but still very satisfying when you finally see the bikes and riders turning up, tired and dusty after a long ride from what may be the other end of the country.

This year's rally held in what must be one of our country's scenic gems on the shores of lake Te Anau was blessed with hot sunny days and clear blue skies. This certainly contributed to the large group of riders who enjoyed the fabulous ride into Milford Sound.

Catering for breakfasts and evening meals was very capably taken care of by the Te Anau Kepler Lions club who provided excellent and generous meals for our rally entrants with only a very few going into the Te Anau township for meals.

Otago Southland Area member Bob Vercoe and the Mataura Licensing Trust gave us a very professionally run bar serving a wide selection of drinks at very reasonable prices.

Music was supplied courtesy of members' personal play lists through a commercial sound system. It would have been nice to have had a band but the cost of accommodating musicians from as far afield as Queenstown or Invercargill would have made the rally entry fee unacceptable to our members.

As for rally numbers, 157 had preregistered, 122 of these (including partners) were club members, with 35 non members. The breakdown by Area was:

With 10 gate entries, and 4 unable to attend, our total number attending the rally was 163.

Membership Report:

Melissa Shipp presented the membership report.

As at 31 December 2020 we had 369 members, with 42 new members joining in 2020. We had 30 members not renew their membership. John W explained some of the reasons behind the non-

Treasurer's Report:

Melissa Shipp presented the treasurers report constructed by Sandy Snell

Melissa advised that the 'computer' held by her was destroyed a couple of years ago as was broken, this needs to be removed from the asset list. Melissa moved a motion "that the computer detailed as held by her be removed from the asset list". This was adopted and approved by all members present.

Wayne Woodward (195) questioned the cash in bank value on the report. Melissa explained how this is made up from. John Witherington explained how being part of an Incorporated Society means we need to include all cash and assets in the Balance Sheet.

John Witherington also explained pecuniary gain to all members.

Sonya McIntyre (483) asked how are we to record income for a specific event if it is 2 or 3 years in the future. John Witherington explained that if it is recorded as money to be used for all members to access for an event that would be acceptable.

Wayne Woodward (195) asked are area's going to be asked how to use funds. John Witherington explained that in the early years of the club there were only 4 areas of TOMCC NZ and those 4 areas discussed at the 2001 National AGM and decided that all area's can keep their own funds raised provided they are used for the purpose of promoting the club and not for pecuniary gain. Ken Spall (157) said all members need to be advised of their area bank account balances and that if any funds are to be used at area level events they are to be notified.

John Milligan (32) objected to the Treasurers Report being adopted.

Melissa Shipp (403) moved the following bank signatories be amended: Remove John Milligan as signatory. Remove Sandy Snell as signatory. Add Clive Barrow as signatory. This was adopted and passed by all members present.

Presidents Report:

John Witherington presented his report, which included:

COVID-19 had played a major part in deciding the location for this year's rally, a number of venues they had looked at after 2020 rally had since closed.

80% of registered participants at this rally had upgraded their accommodation from the standard tent or shared accommodation, which proves that we are, as an aging membership, looking for more comfort when attending a rally.

BEERS AND BIKES





Like most great ideas, this one was formulated in the man cave over a couple of brews.

Canterbury member and racer extraordinaire Pete Williams and I, were talking about his racing and future plans. Pete normally campaigns a '98 Speed Triple 900 and has done very well in his class. But now he was telling me about a relatively new class in Bears Racing — Hinckley Pro Twins, and how last year he ran his 900 Thruxton, and did well, but reckoned with a 1200 Thruxton he could win the class.

Well, I knew of just such a bike sitting around in my garage not doing much. We discussed requirements, and in January this year we stripped all the road gear from it and wired up the required bolts etc. Stripped the airbox, fitted a new set of racing brake pads, and courtesy of Tony Brown of Underground Brown fame who kindly donated a set of new Pirelli Diablo Rosso tyres to the cause, set out to win the title.

The Sound of Thunder on February 26th was the bike's debut. The weather didn't play ball so only a couple of practice sessions were able to be completed on the Friday, with Pete setting lap times around 1min 58 seconds. But we knew there was plenty left.

Saturday morning came and the weather was still a bit damp. Aided by his pit crew chief and partner, Vanessa Somerville, the bike was fettled a little more and Pete set out to get a starting grid position.

He managed to get in the middle of the grid. There are more than one class in these

races, so working out who Pete was actually racing took a bit of time and consultation with the programme. After a couple of races, we worked out who his main rivals where.

The lap times were dropping as Pete became more familiar with the bike. The tyres and pads were scrubbing in nicely as the weather warmed up. Saturday came to a close with a very satisfied Pete and team looking forward to some serious racing on Sunday.

Sunday dawned a little overcast but no rain. So once again we set up, got the tyre warmers sorted and I had a pep talk with Pete. Told him to 'ride like he stole it.' Well, he did, and for the rest of the day he came in first in his class, beating a lot of much more expensive and larger horsepower bikes from other classes.

His lap times were now down around 1min 50. A quick inspection of the foot pegs told me he was giving it his best with the hero tabs ground off and now working on the outer edges of the pegs themselves. The tyres were starting to show some serious wear, the chicken strips were completely gone with balls of rubber all around the edges, though Pete said he was happy with the tyres and they never let go at any time.

Racing is much more enjoyable to watch when you have some skin in the game and we came away with the class win and talked of maybe doing a few upgrades to the Thruxton and having another go next year.




